The Lake Pointe Municipal Utility District (LPMUD) is currently seeking a dedicated individual to serve as a Director on our Board of Directors. This is an exciting opportunity to help guide the strategic direction of our utility district and ensure responsible management of resources for our community.

About Lake Pointe Municipal Utility District:

LPMUD provides essential services to our residents, including the landscaping of common areas and district ponds, ensuring efficient stormwater drainage, and maintaining community amenities such as the Lake Pointe Preserve, Vista Pointe Park, and Lake Austin swim dock on Lake Austin. Our mission is to maintain high standards of accountability while meeting the evolving needs of Lake Pointe residents.

Responsibilities and Accountabilities:

Directors play a crucial role in the following areas:

- **Strategic Planning:** Collaborating with the Board to develop long-term goals for the District.
- **Financial Oversight:** Exercising fiduciary responsibility by overseeing finances, budgeting, and financial performance.
- **Bond Project Management:** Providing oversight for significant ongoing bond-funded infrastructure projects, such as the Lake Austin Dock construction, Vista Pointe Park improvements, and the neighborhood wall replacement.
- **Infrastructure Development:** Contributing to decisions regarding the reimbursement resolution and bond application process, including the amendment of preliminary engineering reports to reflect current project costs.
- **Policy & Compliance:** Participating in the development and review of policies, procedures, and regulations governing the operations of the district, while ensuring compliance with industry standards and legal requirements.
- **Community Engagement:** Serving as a liaison to residents to foster open communication and address community concerns.

Committee Leadership and Special Assignments:

Directors are expected to chair or co-chair subcommittees to ensure all District business receives appropriate attention. These subcommittees currently include Facilities, Preserve, Communications, Finance & Audit, Outreach, and Lake Pointe Projects. To ensure all items under the purview of the Board of Directors receive appropriate attention, each director is expected to actively contribute to several subcommittees.

Compensation and Reimbursement:

Please note that this is a paid position rather than a volunteer role. As outlined in Texas Water Code Section 49.060, Directors are entitled to receive a fee for each day spent performing official duties, subject to an annual limit, as well as reimbursement for reasonable expenses.
